(1) Choose a suitable storage place

The warehouse and cargo yard where fuel pump SCV valve is stored should be kept clean and dry, and away from the factory buildings that generate harmful gases and dust; do not mix with acid, alkali, salt and other substances; the storage place should have a good drainage system; the cargo yard should be flattened with gravel or furnace ash etc. to enhance the water permeability of the surface layer to keep the reservoir area dry.

(2) Strict requirements of warehousing

Strict inspections should be carried out when fuel pump SCV valves are put into storage, the surface

The relative humidity is usually below 70% for fuel pump SCV valves placed in the room, and the corrosion of fuel pump SCV valves is significantly reduced.

fuel pump SCV valves must be stored in the warehouse, and they are forbidden to store in the same warehouse with commodities with high water content.

(4) Stack Properly

After the fuel pump SCV valve is exposed in rain, the corrosion rate will increase significantly. The purpose of sealing is to isolate the fuel pump SCV valve from rainwater and humid air, so the warehouse window should be checked in time to avoid rainwater entering the warehouse

If fuel pump SCV valve package is damaged, it should be repaired or replaced; when the package is damp, the packaging material should be dried; if the original anti-corrosion and oil applied at the factory is found to be damaged or dried up, it should be cleaned and re-applied oil in time.

It is forbidden to leave the fuel pump SCV valve exposed in the air for a long time.

▲ It is forbidden to store acid, alkali, salt and other substances together with the fuel pump SCV valve.

▲ The unpacked fuel pump SCV valve must be rust-proof during secondary storage.
